3. A record of all courses and training material revision status carried out in accordance with this approval including copies of all certificates issued must be available for inspection by authorized officers of this Authority.
4. Submission of any revisions to the applicable course material to this Authority.

The Authority may carry out an audit to ensure continued compliance with the procedures listed in your submissions.

This approval shall have effect from the date hereof until the 09th June 2018, unless varied, suspended or revoked.
